- 7. Students are not permitted to resort to strikes and demonstrations. Participation in any such activity shall automatically result in their dismissal from the Institute. Any problems athey face can be represented to the Heads of Departments concerned or to the Prinicpal.
- 8. The Institute premises and building should be kept clean. Writing and sticking-up the posters and notices on the walls in strictly prohibited. The Institute's property must be safeguarded as their own property.
- 9. The Institute has full powers to suspend, in cases fine, rusticate or to take action which is deemed necessary in the case of any indiscipline on the part of the students.
