The Members discussed the R20 of M.Tech & MCA Regulations and also discussed few amendments in R18 of B.Tech Regulation.

Item No 2: Securitization and approval of B. Tech, M. Tech, MBA and MCA academic regulations of all courses as given in Annexure-II.

The Principal Proposed R20 Regulation of M. Tech and MCA to the Academic Council members. The Committee accepted the R20 Regulation of M.Tech and MCA with few modifications as mentioned below:

Item No 2.1: R20 MCA Clause 5 Supplementary Examinations:

The student eligible to appear the supplementary external examinations, if he/she was absent for it or failed in it or not registered in regular examination. However, for II year II semester students, there will be an Advanced Supplementary examination conducted on request of the students.

The Academic Council members are Accepted and approved the Course Structure of B.Tech., R18 (Phase -II) of III & IV years and also approved the Course Structure of R20 M. Tech and MCA Regulations

Item No 4: To approve the syllabus which was discussed in Board of Studies (BoS) of each department.

Item No. 6: To approve the constitution of Results Committee and Moderation Rules, Promotion rule for B.Tech.

The Principal presented members of results committee and also proposed modifications in special moderation rules and promotion rules for R18 and R20 Regulations of B. Tech., M. Tech., MBA and MCA with effect from the academic year 2020-21 to the academic Council members. The Committee accepted all the proposals.

GENERAL MODERATION RULES

There is no change in the existing rules in general Moderation.

SPECIAL MODERATION RULES

Existing:

The Results Committee will peruse the results as tabulated by the office of the CE and decide upon the need to have special moderation in one or more theory subjects of end examinations only under the following conditions.

- ❖ Abnormal failures/Poor results with or without comments from faculty concerned.
- ❖ For any other reason the results committee may feel.

Special moderation if any, may be allowed both for regular and Supplementary examinations, Special Moderation marks, in each subjects shall be decided by the results committee on case basis. No moderation is allowed for Practical Examinations and PG courses.

At each of the results committee meeting resolutions are to be passed and recorded and the results are to be finalized accordingly.

Special Moderation shall be allowed only in those cases, where the student gets pass marks in that paper when both the special moderation and general moderation applied.

After applying special moderation the maximum score in that subjects shall in no case exceed 95%. However if the score in the subjects before special moderation is more than 95% the same score is to be retained.

Approved

It is approved to have special moderation in one or more theory subjects of end examinations only, under the following conditions.

- If the pass percentage in a subjects is less than 50%, external marks of 1.5% of total marks of all theory subjects in that semester/ year may be added to all candidates who appeared for that subject and secured at least one mark.
- Special moderation, if any, may be allowed for regular examinations only.
- After applying special moderation, the maximum score in that subject shall, in no case, exceed 95%. However, if the score in the subject, before special moderation is more than 95% the same score is to be retained.

PROMOTION RULES

Existing:

A student shall be promoted from II to III year only if he / she fulfils the academic requirement of securing 40% of the credits in the subjects that have been studied up to II year II semester from the following examinations, if any fraction shall be rounded off to the next higher credit.

For I/I sem one regular and two supplementary examinations

For I/II sem one regular and one supplementary examinations.

For II/I sem one regular examinations.

For II/II sem one regular examinations.

A student shall be promoted from III year to IV year only if he / she fulfils the academic requirements of securing 40% of the credits in the subjects that have been studied up to III year II semester from the following examinations, if any fraction shall be rounded off to the next higher mark.

For I/I sem one regular and four supplementary examinations.

For I/II sem one regular and three supplementary examinations.

For II/I sem one regular and two supplementary examinations.

For II/II sem one regular and one supplementary examinations.

For III/I sem one regular examinations.

For III/II sem one regular examinations.

Approved:

A student shall be promoted from II to III year only if he / she fulfils the academic requirement of securing 40% of the credits in the subjects that have been studied up to II year II semester from the following examinations, if any fraction shall be rounded off to the next higher credit.

For I/I sem one regular and two supplementary examinations

For I/II sem one regular and two supplementary examinations.

For II/I sem one regular examinations.

For II/II sem one regular examinations.

A student shall be promoted from III year to IV year only if he / she fulfil the academic requirements of securing 40% of the credits in the subjects that have been studied up to III year II semester from the following examinations, if any fraction shall be rounded off to the next higher mark.

For I/I sem one regular and four supplementary examinations.

For I/II sem one regular and four supplementary examinations.

For II/I sem one regular and two supplementary examinations.

For II/II sem one regular and two supplementary examinations.

For III/I sem one regular examinations.

For III/II sem one regular examinations.

Item No7: Proposal for Changes in Evaluation Systems

The Principal proposed the following items for the discussion and the Academic Council approved.

Item 7.1: Issue of photocopy of answer script.

A Candidate can request for the photo copy of answer script of any theory examination within one week after declaring the results by paying fee. This is implemented to all years and all regulations of B. Tech., M. Tech., MBA and MCA with effect from the academic year 2020-21.

The Academic Council members accepted and Suggested the fee of Rs.750/-

(Rupees Seven Hundred and Fifty only)

Item 7.2: Challenge Valuation.

A student can apply for Challenge valuation by paying prescribed fee. Challenge Valuation shall be carried out by an External Subject expert not less than Associate Professor Cadre. The challenge valuation should be done strictly as per the scheme of valuation supplied by the Examination section in the presence of the Principal, Controller of Examinations. This is implemented to all years and all regulations of B. Tech., M. Tech., MBA and MCA with effect from the academic year 2020-21.

The Academic Council members accepted and suggested the fee of Rs. 4000/- (Rupees four Thousand only)


Item 7.3: Question Bank.

The Principal also proposed to introduce paper setting from the Question Bank. The question bank will be prepared by External expert and has to be approved by the Internal BoS. During the examination date by using software the question papers will be generated. This is implemented to all years of B. Tech. and MBA under R18 regulations, M. Tech., and MCA under R20 regulations with effect from the academic year 2020-21

Item 8: Any Other items suggestions from Academic Council Members.

University Nominees suggested to conduct Academic Council Meeting regularly. Industry Experts suggested to Introduce the Mandatory Internship and Industrial Visits with credits from next regulation to all branch of students. University Nominees suggested that new Regulation MCA may follow advanced Supplementary Examination but not to follow for R18 MBA course.
